The Women's Caucus for Art (WCA) is proud to announce the recipients for the 30th Annual Lifetime Achievement Awards: Maren Hassinger, Ester Hernandez, Joyce Kozloff, Margo Machida, and Ruth Weisberg. The WCA will honor the recipients during their annual conference, held in conjunction with the College Art Association conference in February 2009. The awards ceremony and dinner honoring the recipients will take place at the Wilshire Grand Hotel, 930 Wilshire Boulevard in Los Angeles, California, on Saturday, February 28, 2009. LAA dinner is at 6:30-7:30 and the ceremony is at 7:30-9:00pm. The ceremony and dinner are open to the public.

The Lifetime Achievement Awards were first presented in 1979 in President Jimmy Carter's Oval Office to Isabel Bishop, Selma Burke, Alice Neel, Louise Nevelson, and Georgia O'Keeffe. Past honorees have represented a full range of distinguished achievement in the visual arts from artists to art historians to museum professionals. This year's awardees are no exception; they represent a wide range of involvement and activism in the arts.

The 2009 President's Awards will be given to Susan Fisher Sterling, Director of the National Museum of Women in the Arts, and Catherine

The National Board meets on Monday, March 2, and all WCA members are invited.

National and Local News

The death of the American artist Andrew Wyeth sparked a wide outpouring of appreciation and remembrances. The Philadelphia Inquirer sums up the diverse reaction in many quarters to Wyeth: "The public loved his work, but many critics and scholars considered him an illustrator like his father, N.C. Wyeth, rather than a major artist." President-elect Barack Obama on Saturday retraced part of the train route taken by his political hero Abraham Lincoln to his inauguration in 1861 from Philadelphia, Pennsylvania to Washington, where Obama will be sworn in on Tuesday as the nation's 44th president. Millions of Americans are expected to honor Dr. Martin Luther King, Jr. this Monday, January 19th. More than 11,400 service projects are taking place across the country, more than double last year. Americans will make it "a day on, not a day off" by delivering meals, refurbishing schools, reading to children, signing up mentors, and much, much more. The Chicago Art Deco Society, a revitalized non-profit, has embarked on the first complete survey of Art Deco in the city. The style had its heyday during the 1920s and 1930s and is most visible in such landmarks as the Chicago Board of Trade Building. The survey, designed to locate hidden gems, will be carried out on

foot, by bicycle, by car and on public transit. Sponsored by the **Richard H. Driehaus Foundation of Chicago**, the exercise will provide content for a still-to-be-published book on Chicago Art Deco. Lilly Ledbetter Fair **Pay Act** passes US House handing labor an early victory in the new Congress. The bill is synonymous with Lilly Ledbetter, an Alabama woman whose case against Goodyear was thrown out by the Supreme Court last year. The bill would overturn the Supreme Court ruling and let workers challenge each paycheck as a separate act of discrimination.

Censorship Watch, contributed by Arlene Rakoncay

Reported by The National Coalition Against Censorship Newsletter: A sculpture of the Kokopelli, a Native American fertility god and healer, was moved from the front of Edge of the Cedars State Park Museum in Blanding, Utah after a local group calling itself the "Values Committee" threatened a protest because the sculpture has a penis.

Reported by the Chicago Reader: an installation by Jenny Ramos for the "Department (Store)" show at the School of the Art Institute was asked to remove any prescription medication in her installation. The installation has more than a 100 locked glass display cases, with a different artists' installation in each. Her installation "Pills" displayed about 2,500 tablets and capsules, including some that were prescribed for her. She wanted the installation to convey "the commercialization of medicine in America." She had to pull 236 pills of which only 36 were narcotics. The school claimed they were enforcing safety and security guidelines for the exhibition. Ramos denied she was told about the guidelines and the removal compromised the integrity of her work.

Executive Exits by Katherine Raz, A/C, gapersblock.com

Is the volatile arts climate is having its effect on Chicago theater administrations? Last week Court Theatre executive director Dawn Helsing announced her resignation. On Tuesday Redmoon Theater's executive and artistic directors, Jim Lasko and Christopher Schram, announced theirs.

While it may be easy to blame the recent moves on today's shaky financial scene, it should be noted that under Helsing's direction Court increased its annual budget from \$2.5 to \$3.2 million and saw its biggest hit to date in Caroline, or Change (which was on seemingly everyone's top 10 list last year). Redmoon may not be sitting as pretty -- the company announced it is contracting in size and will produce fewer shows on their home stage this year -- but its current production, Winter Pageant Redux, recently extended.

It's no picnic to lead an arts organization through an economic downturn, especially for administrators who'd rather focus on making plays for audiences than making spreadsheets for board members. (As Lasko's open resignation letter states, "I relish the opportunity to focus more purely on my artistic practice. Organizational leadership, like parenting, is a heavy load.") So it seems likely that this recent trilogy of arts administrators won't be the only ones to get shaken out of the trees, nor will their successors be the only fresh faces on the Chicago theater scene once this crisis is behind us.
