Call for Curatorial Proposals:

CAA invites curators to submit proposals for exhibitions whose openings coincide with the 2010 Annual Conference in Chicago. Exhibition must be held in the conference city and on view during the conference dates: February 10–13, 2010. Deadline: September 1, 2008.

There are no limitations on the theme or media of work to be included in the exhibition, except that it must be a group show of contemporary art, comprising about fifteen artists. CAA's Exhibitions Committee reviews and evaluates proposals based on merit. CAA provides support for the exhibition with a grant of up to \$10,000. An additional grant of \$5,000 is available for an exhibition catalog to be printed in sufficient numbers for distribution to all Annual Conference attendees. Preference is given to those proposals that include both an open call and some CAA members among the exhibiting artists. Proposals must be submitted by e-mail and should include the following information:

- Name(s) of curator(s) or organizer(s), affiliation(s), and CV(s)
- A brief statement of 250 words or less describing the exhibition's theme and explaining any special or timely significance it may have.
- Identification of the designated venue, including a brief description of the exhibition space, its staffing and security features, and the approval for this exhibition by the venue's appropriate officer or authority; a space of no less than three thousand square feet is highly recommended
- A detailed exhibition budget for expenses and income, showing other anticipated sources of funding or in-kind support

Washington DC Area is served by many airlines at three airports: Reagan National (DCA) in Washington DC, Dulles (IAD) (23miles from National Airport in Virginia), and Baltimore Washington (BWI) between Washington DC and Baltimore (27 miles from National Airport).

There are taxis at all three airports. However it may be VERY expensive to take a taxi or shuttle from Dulles and Baltimore Washington airports because they are so far from the Washington Area.

There is a Metro stop at National Airport. Dulles and Baltimore Washington airports both have shuttles to the Metro. Sharing a taxi (if going to the same destination) or taking a cab from the Metro closest to your destination may be cheaper.

Update (as off July 9, 2008):

Illinois Restores \$4 Million for Arts Education

On Wednesday, July 9, Gov. Rod Blagojevich signed a state budget into law after vetoing \$1.4 billion in initiatives.

Thanks to the consistent efforts of arts advocates like you, they are proud to report that funding for the Illinois State Board of Education's Arts and Foreign Language Grant Program has been restored at \$4 million! This reinvestment in arts education is a significant victory for schools and school children throughout the state.

National Endowment for the Arts

The House Interior Appropriations Subcommittee, which sets the initial funding level for the National Endowment for the Arts (NEA), approved a \$15.3 million increase for the NEA in its FY 2009 spending bill. Chairman Norm Dicks (D-WA) has once again proposed an increase in funding for arts and culture in the face of a dramatic cut proposed by the president's recent budget.

Currently funded at \$144.7 million, this increase would bring the agency's budget to \$160 million. President Bush requested a cut to \$128 million for the NEA for FY09 from the current \$144.7 million level. On Arts Advocacy Day, Americans for the Arts presented a panel of witnesses before Chairman Dicks' Appropriations Subcommittee calling for a significant increase in funding for the NEA. Witnesses included actor/director Robert Redford, musician John Legend, and actor Kerry Washington. Next Steps:

The FY 2009 Interior Appropriations bill will next go to full committee and then to the House floor for final consideration where your help may be needed to defend against floor amendments attempting to cut this increase. CENSORSHIP INFORMATION

The Spertus Museum announced today that its controversial mapping exhibit "Imaginary Coordinates," originally scheduled to run through September 7, will close "immediately."

The exhibit, which opened May 2, put antique maps alongside the work of contemporary Palestinian and Israeli artists, in an attempt to "understand the limits of mapping." According to a Spertus statement, it drew criticism for conveying "anti-Israel points of view."

It was shut down once before this, ostensibly due to maintenance issues; when it reopened a week later, it had been rearranged and was accessible only on guided tours.

Apparently that didn't satisfy the exhibition's critics. In today's announcement, Howard A. Sulkin, president of the Spertus Institute of Jewish Studies, which includes the museum, said, "When you take risks, you learn things. . . . This exhibition caused pain for members of our audience. . . . As we grow into our new space [which opened last fall], we are still learning how to balance our new programming and new audiences with sensitivity to our core constituents."

In a highly publicized incident this March, the San Francisco Art Institute cancelled Don't Trust Me, an exhibition by Algerian-born French artist Abdel Abdessemed consisting of video footage of animals being killed by a single blow from a sledgehammer. The cancellation of both the exhibition and a planned panel discussion about the work, came in response to threats of violence directed at staff members and their families by animal-rights activists. Can moral outrage ever justify such threats?

The images in Don't Trust Me are deeply disturbing, though probably less so than videos of animal abuse distributed for advocacy purposes by some of the animal rights organizations that protested the exhibition. The difference is that Abdessemed's videos lack context, and thus offer no clear moral message. Had Abdessemed stated that his work condemned practices of slaughtering animals in Mexico (where the footage was ostensibly shot), for instance, it seems unlikely that SFAI would have been subjected to the threats that caused it to cancel the exhibit.

VOLUNTEER OPPORTUNITIES

March was Women's History Month, and since we are a woman's organization, it seems relevant to remind all of us just how far we have come. For the first time we had a female presidential candidate, a female Secretary of State and a female Speaker of the House. There are 13 women around the world who are elected heads of state. Women are now CEO's of big corporations; there are women generals in the service and more than 200,000 women in the service. But, we still lag behind males in our earning capacity. In the art world there are more and more women curators in art museums and many more women exhibit in galleries than years ago. The Museum of Contemporary Art hired Madeleine Grynsztejn in the position of Director just recently.

WCA was founded to help fight for women's rights in the art world and to educate the public about the contributions of women. Now more than ever we feel we must keep women's art organizations going. Therefore, we are appealing to all of our members to make CWCA as viable, helpful, and useful as possible. We need you to volunteer and participate in our programs and events.
